

IPAF MCWP Demonstrator training.



AIM

To instruct the trainee to safely operate and demonstrate the use of various types of Mast Climbing Work Platforms (MCWP), and to enable them to select and plan the use of MCWP's on a particular job site. This includes familiarisation of the Users with their responsibilities, demonstrating pre-operational checks, safe operating procedures and the limitations of MCWP's.

Course entry criteria:

As the assembly and use of MCWP's can be physically demanding, users should be physically fit and in good health and should, **generally**, not have problems with eyesight or hearing, heart disease, high blood pressure, epilepsy, fear of heights/vertigo, giddiness/difficulty with balance, impaired limb function, alcohol or drug dependence or psychiatric illness. If you have any problems with literacy or language comprehension or have any doubts about your fitness to use MCWP's, you must bring them to the attention of your employer. This need not preclude you from using MCWP's, provided your employer conducts an assessment and is able to put into place adequate measures, to take account of any difficulties you may have.

If any modules required for this application have been completed more than two years prior to application, then the theory tests for those modules (if any) should be retaken and re-assessed.

Training modules:

- Basic health and safety Awareness.
- Basic MCWP awareness, Regulations & guidelines.
- Product Specific – Operational controls.
- Product Specific – Emergency Systems.
- Pre use / Daily checks.
- Retrieval of information.
- Demonstrational ability.
- Weekly inspection.

Course format:

This course comprises of both theoretical and practical training, with written and practical assessments.

Assessment:

Will be by both practical and theoretical test, with a pass requiring an achievement of at least 80% in each assessment. The assessment of each module will be reviewed with the candidate at the end of the training to allow feedback and comments. Those who successfully complete the course will receive an "IPAF PAL card" for "**MCWP Demonstrator**".

Course Details:

- The duration of this course is 1 day depending on experience and knowledge of MCWP's.
- Group size of 3 – 6 persons
- Minimum age is 18.
